**COUNT 6:**

The Grand Jury charges: That on or about June 4, 2022, in Green County, Kentucky, the above-named defendant threatens to commit any crime likely to result in death or serious physical injury to another person or likely to result in substantial property damage to another person or intentionally makes false statement for the purpose of causing evacuation of a building, place of assembly, or facility of public transportation or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 7:**

The Grand Jury charges: That on or about June 4, 2022, in Green County, Kentucky, the above-named defendant intentionally or wantonly causes physical injury to another person; or with reckless he causes physical injury to another person by means of a deadly weapon or a dangerous instrument or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 4:**

The Grand Jury charges: That on or about May 21, 2022, in Green County, Kentucky, the above-named defendant knowingly and unlawfully possessed marijuana or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 5:**

The Grand Jury charges: That on or about May 21, 2022 in Green County, Kentucky, the above-named defendant when he or she: in a public place and with intent to cause public inconvenience, annoyance, or alarm, or wantonly creating a risk thereof: engages in fighting or in violent, tumultuous, or threatening behavior; make unreasonable noise; or refuses to obey an official order to disperse issued to maintain public safety in dangerous proximity to a fire, hazard, or other emergency; or creates a hazardous or physically offensive condition by any act

that serves no legitimate purpose or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.
