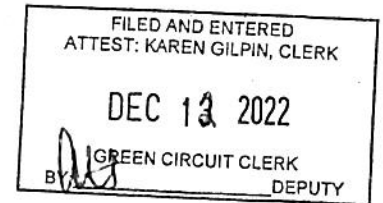

COUNT 2:



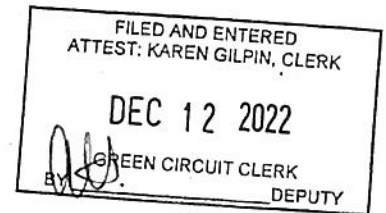

COUNT 2:



COUNT 3:




COUNTS 3-4

The Grand Jury charges that on or about June 2, 2019 through June 3, 2019, in Green County, Kentucky the above-named defendant subjects another person to sexual contact by forcible compulsion or he subjects another person to sexual contact who is incapable of consent because he or she is physically helpless; is less than twelve (12) years old or is mentally incapacitated or being twenty-one (21) years old or more, he subjects another person who is less than sixteen (16) years old to sexual contact; engages in masturbation in the presence of another person who is less than sixteen (16) years old and knows or has reason to know the other person is present; or engages in masturbation while using the Internet, telephone, or other electronic communication device while communicating with a minor who the person knows is less than sixteen (16) years old, and the minor can see or hear the person masturbate; or being a person in a position of authority or position of special trust, as defined in KRS 532.045, he regardless of his or her age, subjects a minor who is less than eighteen (18) years old, with whom he or she comes into contact as a result of the position, to sexual contact or engages in masturbation in the presence of the minor and knows or has reason to know the minor is present or engages in


masturbation while using the internet, telephone, or other electronic communication device while communicating with a minor who the person knows is less than sixteen (16) years old, and the minor can see or hear the person masturbate or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.
