## COUNT 1:

The Grand Jury of Adair County, Kentucky, charges that on or about November 22, 2025, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant operated a motor vehicle which did not display at the rear of the motor vehicle two (2) red lights visible when lighted for at least five hundred (500) feet, against the peace and dignity of the Commonwealth of Kentucky.

## COUNT 2:

The Grand Jury of Adair County, Kentucky, charges that on or about November 22, 2025, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant operated a motor vehicle on the left side of the roadway when approaching or upon the crest of a grade or a curve in the highway where his view was obstructed within such distance as to have created a hazard in the event another vehicle might have approached from the opposite direction; or approaching within one hundred (100) feet of or traversing any intersection or railroad grade crossing; or when his view was obstructed upon approaching within one hundred (100) feet of any bridge, viaduct or tunnel, against the peace and dignity of the Commonwealth of Kentucky.

## COUNT 3:

The Grand Jury of Adair County, Kentucky, charges that on or about November 22, 2025, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant operated or was in physical control of a motor vehicle at such time as the Defendant had an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a

sample of the Defendant's breath or blood taken within two (2) hours of cessation of operation of physical control of a motor vehicle; or while the Defendant was under the under the influence of alcohol; or while the Defendant was under the influence of any other substance or combination of substances which impaired the Defendant's driving ability; or while the presence of a controlled substance listed in KRS 189A.010(12) was detected in the Defendant's blood, as measured by a scientifically reliable test or tests taken within two (2) hours of cessation of operation or physical control of a motor vehicle; or while the Defendant was under the combined influence of alcohol and any other substance which impairs one's driving ability, this being his first such offense within a ten (10) year period, and the Defendant refused to submit to any test or tests of his blood, breath, or urine requested by an officer having reasonable grounds to believe the Defendant was operating or in physical control of a motor vehicle in violation of Subsection (1) of KRS 189A.010, against the peace and dignity of the Commonwealth of Kentucky.

## COUNT 4:

The Grand Jury of Adair County, Kentucky, charges that on or about November 22, 2025, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant, while operating a motor vehicle with the intent to elude or flee, he knowingly or wantonly disobeyed a direction to stop his motor vehicle, given by a person(s) recognized to be a police officer, and the defendant was driving under the influence of alcohol or any other substance or combination of substances in violation of KRS 189A.010; and/or by fleeing or eluding, the defendant was the cause, or created a substantial risk, of serious physical injury or death to another person(s) or property, against the peace and dignity of the Commonwealth of Kentucky.

## COUNT 5:

The Grand Jury of Adair County, Kentucky, charges that on or about November 22, 2025, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant intentionally prevented or attempted to prevent Columbia Police Officer Tyler McKinney and/or other law enforcement officers, who were recognized to be acting under color of official authority, from effecting an arrest of the defendant by using or threatening to use physical force or violence against Columbia Police Officer Tyler McKinney and/or other law enforcement officers, or by using any other means creating a substantial risk of causing physical injury to Columbia Police Officer Tyler McKinney and/or other law enforcement officers, against the peace and dignity of the Commonwealth of Kentucky.

## COUNT 6:

The Grand Jury of Adair County, Kentucky, charges that on or about November 22, 2025, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant knowingly and unlawfully possessed marijuana, against the peace and dignity of the Commonwealth of Kentucky.

## COUNT 7:

The Grand Jury of Adair County, Kentucky, charges that on or about November 22, 2025, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant operated a motor vehicle on a highway in a manner that was without regard for the safety and convenience of pedestrians and other vehicles upon the highway, against the peace and dignity of the Commonwealth of Kentucky.

## COUNT 8:

The Grand Jury of Adair County, Kentucky, charges that on or about November 22, 2025, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant operated a motor vehicle on N. KY 55, and/or Loveless Road, and/or Cane Valley Road, and/or Vanhoy Lane, and/or Holmes Bend Road, and/or KY 551, and/or Campbellsville Highway, and/or N. KY 55, and/or Burkesville Road, and/or W. KY 80, and/or back onto Burkesville Road, and/or Campbellsville Street, and/or N. High Street, and/or West Adams Alley, at speeds in excess of twenty-six (26) miles per hour greater than the posted speed limit, against the peace and dignity of the Commonwealth of Kentucky.

## COUNT 9:

The Grand Jury of Adair County, Kentucky, charges that on or about November 22, 2025, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant committed the offense of Wanton Endangerment in the First Degree when, under circumstances manifesting an extreme indifference to human life, he wantonly engaged in conduct which created a substantial danger of death or serious physical injury to another person(s) by operating a motor vehicle in a wanton manner during a police pursuit and thereby endangering the life of Adair County Deputy Sheriff Joey Keith, against the peace and dignity of the Commonwealth of Kentucky.




